Terms and Conditions and Rental Agreement

10 yard - \$370, includes 1 ton of waste.

20 yard - \$505, includes 2 tons of waste.

30 yard - \$640, includes 3 tons of waste.

Above and beyond allowed tons is \$120/ton.

Unacceptable Items: Branches, Dirt, Trees, Yard Waste, Leaves, Hazardous Waste (including Oil, Antifreeze, Gas, etc), Medical Waste, Paint, Propane Tanks, TVs, Computers and E-Waste.

Appliances are acceptable in roll off. Please do not overload.

Fridges, freezers, items with freon are accepted inside roll off with an additional cost of \$35/item.

Car tires are acceptable in the roll off with a cost of \$8 and truck tires are acceptable in roll off with a cost of \$15. Additional \$2 for rim. NO OVERSIZED OR LARGE TIRES.

Standard roll off rental is 14 days. Contact us for options for keeping the roll off longer than the standard period. Please contact us when you are done with the roll off to schedule pick up.

Roll off prices include a maximum number of tons. If the roll off exceeds the maximum number of tons, you will be charged **\$120/ton for overages**. Roll off contents are not to exceed 6 tons.

Full payment is required prior to delivery. We accept cash or check upon delivery or credit card over the phone. There is a \$15 credit card processing fee.

Roll offs need to be loaded evenly.

Items cannot protrude over the top of the roll off. Any item protruding over the top of the roll off or any roll off that requires reloading is subject to additional charges and possible removal from the roll off.

The customer is responsible for any damage to the roll off while in their custody.

Do not allow children to climb or play on/in roll offs.

Additional charges will be incurred if we are unable to deliver or pick up a roll off on scheduled dates. Please be sure roll off area is clear for safely loading and unloading.

LOCALLY OWNED – LOCALLY OPERATED

The customer does not need to be present for delivery. If you are not present, please make sure you provide us with clear and precise directions for delivery and make sure the area is clear and easily accessible. Olson Sanitation and its drivers have the ultimate say in placement for a roll off.

Olson Sanitation and its drivers are not responsible for any damage to lawns or driveways caused from delivery/pickup or the roll offs.

Any costs associated with an overweight roll off or unacceptable material is the sole responsibility of the customer.

Any attorney or court fees incurred for disputes are the sole responsibility of the customer.

Payment is due within 30 days of sale. A 3% per month (36% per year) late payment fee will be assessed on any unpaid balance remaining after 30 days.
